### NOTIFICATION

**No. ED 251 DPI 2009 (P), Bangalore, Dated: 18/04/2012**

Whereas, the draft of the following rules further to amend the Karnataka Education Department Services (Department of Public Instructions) (Recruitment) Rules 1967, was published as required by clause (a) of sub-section (2) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990), in Notification No. ED 251 DPI 2009 (P), Dated: 27/01/2012 in Part IVA, in No: 66 of the Karnataka Gazette (Extraordinary) Dated: 30/01/2012, inviting objections and suggestions from all persons likely to be affected thereby, within fifteen days from the date of its publication in the Official Gazette.

Whereas, the said Gazette was made available to the public on Dated: 30/01/2012

Whereas, no objections / suggestions has been received in this behalf by the State Government.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990), the Government of Karnataka hereby makes the following rules, namely:-

### RULES

**1. Title and commencement.-** (1) These rules may be called the Karnataka Education Department Services (Department of Public Instructions) (Recruitment) (Amendment) Rules, 2012.

(2) They shall come into force from the date of their publication in the official Gazette.

**2. Amendment of Schedule.-** In the Karnataka Education Department Services (Department of Public Instructions) (Recruitment) Rules 1967, in the schedule, after serial number 35 and the entries relating there to, the following shall be deemed to have been inserted with effect from 30<sup>th</sup> day of August 2007 namely:-

Note:- A Physical Education Teacher Grade-1 shall exercise an irrevocable option before consideration for promotion.	Must have put in a service of not less than 5 years in the cadre of Physical Education Teacher Grade-1.  "Provided that if an official who has put in service of not less than 5 years is not available, then an official who have put in not less than three years of service may be considered for promotion."
